14	Q. What type of things did you do for Mr. De Niro while you
15	were in a position of director of production?
16	A. I handled creating budgets for him for his films he was
17	acting in, I would put together expenses such as what costs his
18	crew would be, private plane travel, hotels, hotel for family.
19	Just logistics, things that he would need on set so I would
20	create the perk budgets. I would do scouting trips where I
21	would go and see different hotels for him and look for a suite
22	for him but also something for a gym room; he had a gym on
23	every set so we would have a separate room for that. I would
24	meet with production, I would go over the production schedule
25	and any carve-out dates that Bob had that he would not be able

2	prior to filming, also possible script readings that they did

8	A. Yes.
9	Q. Who?
10	A. I worked closely with Peter Grant, Bob's entertainment
11	attorney, and Josh Lieberman, Bob's Agent at CAA.
12	Q. What did you do with Mr. Grant?
13	MR. SCHOENSTEIN: Objection.
14	THE COURT: Basis?
15	MR. SCHOENSTEIN: What is broad, vague.
16	THE COURT: Overruled.
17	A. Sorry. Can you repeat the question?
18	Q. What did you do with Mr. Grant?
19	A. I worked with Peter and Josh together on Bob's contract and
20	his deal when it came to films, commercials, and commercials
21	that he was doing. We would discuss Bob's needs and the costs
22	of it, I would give them estimates on that. And any sort of
23	logistical needs that he would need such as how many private
24	plane trips back and forth, how many hotel rooms, what crew he

13	A. From 2011 to 2017.
14	Q. Did you receive a new title in 2017?
15	A. I did.
16	Q. What was that title?
17	A. VP of production and finance.
18	Q. Who came up with that title?
19	A. I did, after speaking with Bob.
20	Q. Why did you want the title VP production and finance?
21	A. There were a couple of reasons. At that time I had spoken
22	to Bob about transitioning out of Canal Productions and giving
23	him two years so that I could transition out. It would be a
24	good title for what I had spoken to Bob about where I wanted to
25	go with my career, wanting to start my own production company,

20	handles the specific production needs of Bob for the films that
21	he acts in. So not every single film he acts in is something
22	that he produces or that Tribeca produces. Actually, most of
23	what he films has nothing to do with Tribeca Productions.
24	Q. Similarly, there are questions about how Canal doesn't
25	finance anything. Why was the term "finance" in your title?

9	she can testify to why Mr. De Niro approved it. She can

13	Q. Did you discuss with Mr. De Niro wanting to have the new
14	title: Vice president production and finance?
15	A. Yes.
16	Q. With respect to the finance portion, what did you and he
17	discuss?
18	A. We discussed that I had been working on these perk budgets,
19	I had been handling all the expenses and tracking them,
20	invoicing, doing all of these things, but there were a couple
21	other projects that Bob had me do during my time at Canal that
22	had to do with tracking down bills, paying, organizing things
23	such as with his ex-girlfriend Toukie Smith. So, I had been
24	doing a lot of work with her in that area.
25	Q. Did you and Mr. De Niro exchange e-mails about your new

5	Q. Not written, unwritten policy?
6	A. Oh, I'm sorry. I thought you meant written policies.
7	Q. I thought you said there were no written policies?
8	A. There were no written policies.
9	Q. So was there an unwritten policy regarding how much
10	employees could spend on meals?
11	A. Yes.
12	Q. What was that?
13	A. For meals, employees could spend, if they were working, \$10
14	for breakfast, 20 to \$30 for lunch, \$40 for dinner, if they
15	were working or if they were on call.
16	Q. Okay. Was there an unwritten policy regarding when Canal
17	employees could spend money on Ubers or taxis?
18	A. Yes.
19	Q. What was that policy?
20	A. If you were on call, you could use an Uber or taxi so you
21	remained available for Bob. In addition you could use Uber or
22	taxi if you needed to run an errand or do anything work
23	related. So you could either be reimbursed or you could charge
24	it on one of the two Canal Amex cards.
25	Q. Okay. And was there an unwritten policy when it came to

20	an allotment for having higher amount of amount that I could
21	spend in terms of meals. So I could spend up to around \$100 a
22	day for meals if I was working, coffee, snacks things like
23	that.
24	Q. Had you and Mr. De Niro reached an agreement regarding how
25	much you as his lead assistant could spend on taxis or Ubers?

20	A. Office supplies, employee meals, employee transportation,
21	taxis, Ubers, supplies, hotel lodging for Bob that had do with
22	his business, not personal travel. Things like that.
23	Q. I may have missed it, did you mention employee charges for
24	meals on your card?
25	A. Yes.

14	Q. Okay. Let's talk about one in 2008.
15	Did you and Mr. De Niro reach an agreement in 2008
16	with respect to what expenses you could charge?

18	Q. And what did the two of you discuss with respect to the
19	expenses you could charge?
20	A. We discussed the ability and Bob's approval on our taking
21	taxis while I was on call for him.
22	Q. Do you remember the particulars of that discussion?
23	A. I do.
24	Q. Do you remember approximately when it happened?
25	A. It happened at the end of 2008. Like it was dark, so

I hear what you are saying about 95 and 96. I think I ruled with respect to that. I think you had the opportunity to cross-examine with respect to that. The record is what the record will be, but with respect to the question of whether the, to the extent that 95 and 96 were derived from the AmEx records of Canal, whether those AmEx records that were in the 7 possession of Canal are the business records of Canal, you have made an objection. You said, listen, they didn't ask all of the right questions, and there was testimony of the plaintiff that went to that issue. It frankly may be enough to satisfy it.
